
Now this Instrument witnesses & declares as follows:


1. Name : The name of the Trust shall be "ALBAB CHARITABLE EDUCATIONAL TRUST"
2. Address : The Trust will have its head office at Kattoor Village, Mukundapuram Taluk, Thrissur District, Kerala. It is open to the trustees to change the place of office to other places or to open new/additional offices any where in India.
3. Objects : The Objects of the trust are:


- I To spread knowledge and education by the publication of books, classics, audio and videocassettes and other literature or by other modes;
- II To establish and / or contribute to educations and cultural institutions, colleges, schools, libraries, book trusts, reading rooms, technical institutions or other institutions.
- III To hold and promote education and learning including primary, higher and college education, technical, non-technical agricultural, engineering, medical, commercial, scientific, spiritual or any other subject of education and research work in all subjects either privately or in schools, colleges and / or other institutions.
- IV To establish professorships, lectureships and to give scholarships and prizes or any other similar help or encouragement for the advancement of education.
- V To establish, maintain and support or help by monetary gifts or otherwise, institutions such as libraries, fine art classes or institutions and establishments or polytechnic cottage and small scale industries and the like.
- VI To aid by giving scholarships, donation, fees or otherwise to deserving and poor students for their studies, training, research, education etc.
- VII To provide medical relief by giving fees, medicines, injections, tonic, food and the like and by giving help for medical treatment including payment of expenses for such medical treatment.
- VIII To establish, construct, maintain and run hospitals, dispensaries, orphanages, nursing home, clinics, and places of worship for prayer and institutions for the relief of the sick and to aid and co-operate with other institutions and societies doing similar work.
- IX To construct and maintain hall or building suitable for conducting educational meetings, social gatherings, lectures, seminars, free health and medical clamps, poor feedings



houses and model institutions for the crippled, incapacitated, unemployed and illiterate,  
men, women and children for teaching them handicrafts and home industries such as  
carpentry, designing, drawing, painting, spinning, weaving, laundry work, dry clean-  
ing, cutting, confectionery, knitting, sewing embroidery and other handicrafts / indus-  
tries of any kind whatsoever so as to enable them to become useful to the members of the  
public.

- XI To erect, establish, maintain buildings or otherwise, provide housing accommodation to the poor and to establish and maintain sanatorium, public halls and the like in any part of the country and to provide convenience to the persons visiting such places.
- XII To provide for relief of the poor and in particular to help incapacitated persons in poor and destitute circumstances by giving doles in money or in kind, free food, free shelter and the like.
- XIII To take steps to disseminate scientific, technical and cultural knowledge and to raise the standard of life and health among the backward sections of the people.
- XIV To work for upliftment of the people of India socially, educationally and culturally.
- XV To provide educational facilities, free food, clothing, medical treatment, hostel facility etc. and other facilities to children who have lost their parents and to poor students.
- XVI To conduct classes combining spiritual and rational education by commencing board-  
ing schools.
- XVII To work for religious harmony and unity among various sections of the society.
- XVIII To work for eradicating gambling, drugs, alcohols and other social evils.



- XXI To conduct or facilitate to conduct lectures, seminars, symposiums on all subjects.
- XXII To contribute or donate to any benevolent or charitable purposes or to establish funds therefore.
- XXIII To construct new wells and maintain and repair the existing wells, tanks and others sources of water for the benefit of the public and to give monetary help for the same.
- XXIV To establish or help in establishing institutions for the treatment and shelter of the animals.
- XXV To give monetary aid or other help for relief from natural calamities like flood, cyclone, tempest or otherwise.
- XXVI To get published or help in the publication or books audio and video cassettes, periodicals and journals or general public utility and to distribute them freely or as prizes or on payments of their cost or otherwise.
- XXVII For the advancement of any other object of general public utility not involving any activity with the intention to earn profit.
- XXVIII To do all such things as may be necessary or conducive for the advancement of the objects above mentioned.
- XXIX To receive donations, gifts, funds etc. in cash or in kind towards both the corpus of the trust or otherwise from the general public, central or state governments, semi-government institutions, corporations, khadi village industries department and other organizations.
- XXX To receive aid in the form of loans or otherwise from the general public, central or state governments, semi-Government institutions, corporations, khadi village industries department and other organizations for the purpose of facilitating the objects of the trust.
- XXXI The funds of the Trust shall be applied for the aforesaid objects only in India.


#### 4. Trust Fund :






ing the trust for special purposes connected with the objects of the trust not intended to impede the due working day of the Trust, arising from donations and also of any investments for the being representing the same (hereafter called the "TRUST FUND") and also of the net income from the trust fund in trust, to apply both the income and the capital of the trust fund for the purposes of the trust.


- b. It is hereby declared that as on date the Trust does not won any immovable property.


5. Board of Trustees :


- a. Board of Trustees are to govern the full functions of this trust.
- b. From among the Board of Trustees, they have to elect among themselves, one chairman, one secretary, one treasurer, two vice chairmen and two joint secretaries. The elected people can hold office for a period of two years and thereafter, they are eligible of re election.
- c. The full responsibility for the trust funds shall vest with the board of trustees.
- d. Any trustee who act or do anything detrimental to the interest of the trust may be dismissed by the board of trustees at a meeting of the board of trustees specially convened for this purpose by passing a special resolution to this effect approved by a simple majority of the remaining members of the board of trustees.
- e. On death or resignation due to illness of a trustee, his trusteeship will devolve on his nominee.
- f. If any vacancy arises in the board of trustees on account of death or resignation or removal by the board of trustees, the remaining trustees may nominate with the approval of 75% of the existing strength of the board of trustees, any person to fill the vacancy.
- g. The number of trustees of this trust shall be limited to fifteen.
- h. The trustees & thair nominees should be sunni muslims who support shafi e madhab and Ash' ari thvarikath. The board has the right to remove those trustees who work against the rule of ahalusunathi val jammath by passing a resolution as specified elsewhere in this deed.

The board of trustees can form sub-committees when needed for the development of the trust and also can dissolve or suspend it at any time.

- j. The board of trustees can appoint/dismiss/remove any staff, employee and worker as required for the working of the trust.

6. Responsibility of Office bearers.

- a. **CHAIRMAN:** The chairman of the Trust shall have the power to conduct and carry out the affairs of the Trust including calling and conducting the meetings of the Board of trustees and to preside over all the meetings, In his absence at any meeting, any of the Vice Chairmen shall preside over and in their absence too; and one among the other trustees opted by the majority of the trustees present shall preside over such meeting. The chairman should sign the reports, minutes and passed opinions or decisions.
- b. **VICE CHAIRMEN:** The Vice Chairmen shall assist the Chairman in all affairs of the Trust.
- c. **SECRETARY :** The Secretary of the Trust shall have the responsibility and power to correspond, cause circulars, arrange for meetings, and maintain minutes and other documents of the Trust. The secretary shall call and conduct all the meetings of board of trustees with the prior permission of the chairman. It is the responsibility of the secretary to prepare the minutes of the meeting and to prepare and present the annual reports of the trusts in the annual general meeting. The secretary shall represent the trust in all civil, criminal cases and the other statutory matters.
- d. **JOINT SECRETARIES:** The joint secretaries shall assist the secretary in all affairs of the Trust.
- e. **TREASURES :** The Treasurer shall have the power of collecting funds, donations and gifts on behalf of the Trust and issuing receipts for the same, counter signed by any one of the other Trustees. He shall keep true and correct accounts of all the Trust monies and the disbursements thereof.




- b. **QUORUM:** For any meeting of the Board of Trustees, a minimum number of two thirds of the total strength of the Board of trustees shall be present.
- c. **VOTE :** Every trustee shall have one vote with the Chairman having an additional casting vote.
- d. **RESOLUTION:** Resolution/s may be passed by a simple majority of the trustees present and the Chairman shall have an additional casting vote. Resolutions can also be passed in writing by circulation among the Trustees who shall duly sign such resolution / resolutions.
- e. **NOTICE:** A notice of the meeting of the board shall be issued at least three days before the date of meeting. Such notice should be in writing. Further the date of successive meeting or meetings may also be decided in the meetings of the Board in advance. In such and event, no further notice of meeting/s is required to be served. Shorter notices may also be given when such notice is ratified by the trustees in simple majority.
- f. **PLACE:** Meeting may normally be in the registered office of the trust and however the Board may change the venue as may be decided from time to time.
- g. **EXTRAORDINARY MEETING:** The Secretary of the board of trustees has to arrange and conduct an extraordinary meeting of the board of trustees within a period of fifteen days, if two thirds of the total strength of the board of trustees requests him in writing to do so.








- b. To open one or more bank accounts, either over drawn or otherwise, in the name and for the trust anywhere in India and have the power to operate the same as laid down elsewhere in this trust deed.
- c. - g. - h. To settle, compromise or compound all and any of the debts, claims outstanding amounts, disputes demands, auctions, suits and proceedings whatsoever by or against in any manner relating to the trust or refer the same to arbitration.







- j. to decide on various matters relating to the administration of the trust by taking the majority opinion of the members of the board of trustees present. In case of a tie, the Chairman has the power of making a casting vote.
- k. Where ever necessary, to alter and rescind the existing clauses of the trust deed or rules and regulations or to make new clauses and / of rules and regulations for the effective management and administration of the trust. But such alteration or addition or removal should be agreed to by at least 75% of the total strength of the board of trustees.
- l. To raise donations or accept gifts, grants, endowments, ishtadaanams or contributions in cash or in kind from individuals, groups, families associations either incorporated or un incorporated, organizations, governments.
- m. To apply the funds of the trust for achieving the objects. Such application shall include incurring revenue or capital expenditures or repayments and servicing of the loans of the trust.
- n. All decisions taken by a simple majority of trustees shall be binding upon this trust.
9. The trustees shall maintain proper books of accounts of the moneys, properties and income and expenditure of the trust and get the same audited every year by a qualified Chartered Accountant, if required under prevailing laws.
10. The Chairman, The Secretary and The Treasury shall jointly operate the bank accounts of the Trust. Similarly, they should jointly sign and seal all the documents of the firm.
